Introducing IMAGINE



The IMAGINE Project, co-funded by the EU4Health Programme, is working to reduce infections and inappropriate antibiotic use in nursing homes across eight European countries. Aligned with drive-AMS, the initiative combines infection prevention, antimicrobial stewardship, and behavioral science to combat antimicrobial resistance in long-term care facilities.

Rwandan Masterclass

The second drive-AMS Masterclass brought together healthcare teams from across Rwanda for an intensive 3-day training on antimicrobial stewardship. Participants developed real-world intervention projects to improve antibiotic use in their hospitals and got an introduction to Global-PPS. Read more here.

Greek webinars

In January, the Greek team hosted two impactful webinars in focusing on antimicrobial stewardship in pediatric hematology-oncology and hospital pharmacy. Co-organized with <u>EEPAO</u> and <u>PEFNI</u>, these sessions provided healthcare professionals with practical strategies to optimize antibiotic use, foster collaboration, and enhance patient care, reinforcing our commitment to tackling antimicrobial resistance.

Hospital infections course in Portugal

In January, STOP-Hospital Infection 2.0 brought together 350 health professionals in its second learning session to share results, tackle challenges, and strengthen efforts to reduce hospital infections in Portugal. With significant progress in ICU-acquired infections, the program remains committed to achieving its goal of a 50% reduction across four infection types through education, leadership, and behavior change. drive-AMS course in Cyprus

Cypriot hospitals took a major step forward in AMS with the drive-AMS course, a training event held in February. Supported by the Cyprus Ministry of Health and EU-JAMRAI, the Global-PPS team equipped 38 healthcare professionals with Global-PPS feedback reports and a training on interpreting their results, highlighting opportunities to optimize antibiotic use. With expert mentorship and ongoing support, participating hospitals are now set to implement targeted AMS strategies, reinforcing their commitment to combating AMR. Read more here.
